Within our school, your voluntary contributions have allowed us to:

- provide an enriched curriculum in our specialist program

Educational items for students to own

Year Level Leaders have recently spent time assessing the needs of students in each level for next year. Livingstone Primary School highly recommends you purchase year level Student Learning Packs from Maxim for your child to individually own and use. We have also regularly liaised to ensure that competitive pricing remained and that only quality items were considered.



Individual Student Learning Packs (Book Packs). The content of these packs vary between year levels and can be ordered by parents /carers directly from our school supplier. A list of supplies for each year level will be made available on the supplier's portal. The school is not able to pre-purchase and supply these packs on behalf of parents/carers.

The recommended packs can be purchased directly through Maxim and will be available to purchase online from 11th November 2024 through to 20th December 2024. Book packs ordered by the 20th December 2024 will have collection times from the school canteen area on Tuesday 28th January 2025 (8.30am – 6.00pm), Wednesday 29th January 2025 (8.00am – 9.30am) or Thursday 30th January 2025 (3.00pm – 4.00pm). Please note that Foundation packs are given directly to the classroom teacher and are not required to be collected from the school. Orders received by Maxim after 20th December 2024 will incur a late fee of \$15 and will be delivered directly to the school within the first 2 weeks of February 2025. Details on how to order will be posted on Compass.

FREE INSTRUCTION

PARENT PAYMENT REQUESTS

Other Contributions

Voluntary financial contributions for noncurriculum items and activities that relate to the school's functions and objectives.

FINANCIAL HELP FOR FAMILIES
